- Track Contractual Arrangements- same rates as 2018; \$1250/day; \$40 per car & \$30 per cart each day

SWMS 2019 Plan Review-

- Gary led brief update of 2019 Schedule:
- Larry P and Jerry went out to the track and report that corner stations are in better shape than originally thought. Charlie to get some repair materials for minor repairs that should not take much time and effort. Larry P said he plans to purchase plastic chairs for the corner stations.

Tech Pre-check now to be held Mar 9th 10:30 to 2PM at Pulse Star (Steve Marino) due to conflict at track with the Porsche Club. Track/corner worker training to be concurrent. Larry H had about a half page handout re: Pre-Tech procedures that was discussed and while it contained mostly good points also noted some issues remain to be worked out. Ken proposed try the new process and re-examine/critique it after the first race. Larry H's main idea was that Pre-Tech will allow drivers to present three items- Vehicle Log Book w/current annual Tech Sticker; also with personal safety gear sticker; and Pre-Tech and Tech Inspection form to Registrar. If documents are incomplete, driver to then complete event Tech inspection form and pre-race inspection.

There was a discussion of rough track, bumps, and how to best accommodate the carting group (timing loop and bump issues to be resolved on site- Carts likely only Sunday. Everyone encouraged to think about a Drive-Out idea for July-Aug. Sept has been the Annual Chile Cookout at Russ & Karen Kelso's. Sept 28-29 Jerry tentative Race Chair. Larry P suggested adding High Plains Race for Cancer and Steve Marino suggested getting schedule to Emily for website.

Procedures Committee still have about eleven procedures to update per Bob Richards There was a discussion of registration procedure issues of who looks at Log Book for Pre-check OK/competition License number, etc. Gary to work on as may be overwhelming especially early on for Marci.
